1. General

The US Embassy Abu Dhabi invites competitive quotes for providing fitness membership for US Embassy, ODP officers, per the schedule of supplies /services given below. Vendor shall quote net price, inclusive of VAT (if applicable). Based on the RFQ requirements only Gym facilities within Abu Dhabi city area are permitted to submit a quote.

2. Schedule of Supplies /Services

Fitness membership for ODP officers at the US Embassy Abu Dhabi.

Single membership for 15 officers x 12 months (one year)

Quantity: vendor shall quote net amount for one year single membership x 15 each.

Period of Performance: November 1, 2020 to October 31, 2021.

Gym facility shall be offered with a minimum of following equipment/facilities:

1. Gym facility should meet US Government standards for equipment and operation (this will be inspected).
2. Access card for free and easy check-in/check-out to/from the Gym facility.
3. Membership cards for officers shall be issued against US Embassy Purchase Order without additional charges. Vendor should replace or reissue this card(s) to replacement officer(s) when current member transfer from post Abu Dhabi, within the period of performance.
4. Free car parking close the Gym facility/compound.
5. Past experience with US Government is preferable.
6. The gym Facility should be within Abu Dhabi city area.
7. The Facility shall not be attached to any complex shopping mall or congested public area – to ensure the safety and easy check in/checkout of the service members.
8. The Gym facility should follow UAE COVID-19 protocol and be able to operate as per UAE health and safety standards.

3. Qualification of Offerors

Offerors/quoters must be technically qualified and financially responsible to perform the work described in this solicitation. At a minimum, each Offeror/Quoter must meet the following requirements:

- (1) Have an established business with a permanent address and telephone listing;
- (2) Have the necessary personnel, vehicles and financial resources available to perform the work;
- (3) Have all licenses and permits required by local law;
- (4) Meet all local insurance requirements;
- (5) Have no adverse criminal record; and
- (6) Have no political or business affiliation which could be considered contrary to the interests of the United States.
- (7) Gym facility shall be within Abu Dhabi city area and operational without subcontract terms.

In order for a quotation to be considered you must complete and submit the following:

5. Evaluation criteria

(a) Award of purchase order will be made to the lowest priced, acceptable, responsible quoter. The Government reserves the right to reject quotations that are unreasonably low or high in price. The Government will determine acceptability by assessing the offeror's compliance with the terms of the RFQ based on initial quotations without holding discussions. However, we may hold discussions with companies in the competitive range if there is a need to do so.

(b) LATE QUOTATIONS. Late quotations shall be handled in accordance with FAR.

A. NDAA (National Defense Authorization Act) Compliance:

(d) *Comptroller General Examination of Record*. The Contractor shall comply with the provisions of this paragraph (d) if this contract was awarded using other than sealed bid, is in excess of the simplified acquisition threshold, and does not contain the clause at 52.215-2, Audit and Records—Negotiation.

(1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.
